Thank you for your enquiry regarding Membership. The enclosed information may be varied by the Board of Management at its discretion and is intended to provide a brief overview of the Club, costs and waiting time.

Puttenham Golf Club is a private Members' Club. It has standards of behaviour, etiquette and dress which have been set in order to create an atmosphere of conviviality, relaxation and friendliness. It is important to understand these standards and therefore what is expected of each and every member who joins this Club.

The following are the main membership categories and fees for 2010 for men and women (maximum 465 7-day members/90 5-day members):

\* Puttenham is offering at least a 20% discount on the Entrance Fee for two or more more applicants aged 30 or over who join together.

Bar card holders benefit from a 15% discount off all drinks purchases and 10% off bar snack purchases made using their bar card. However, members can choose to opt out of the bar card scheme and pay an in lieu bar charge instead<sup>2</sup>.

In addition, Puttenham is offering a "Temporary Membership" for 60 days during the Summer months at a cost of only £250 with no Entrance Fee. During those 60 days, temporary members can enter Club competitions, hold a handicap, introduce guests at the member's guest green fee rate and use the course, Clubhouse and practice facilities at no extra charge. Applications for Temporary Membership are available on a one-off basis only.

Subscriptions are due and payable annually on 1<sup>st</sup> January. However, payments can be spread quarterly or ten monthly (January to October inclusive) via the Direct Debit payment method. There are additional charges of £2.50 per transaction plus a premium of £10 per annum for using the Direct Debit facility.

Please ask for separate fact sheet and application forms for these categories. Please note that any junior (age under 18) joining at the same time as a relative aged 30 or over will not be charged a subscription for the remainder of 2010. The Entrance Fee and EGU fees still apply.
